I/WE FURTHER DECLARE THAT DURING THE [NUMBER _____] YEARS AFTER THE DATE OF DECLARATION/REGISTRATION, THE MOTOR VEHICLE(S) MENTIONED HEREIN SHALL BE USED EXCLUSIVELY FOR THE PURPOSE OF [NAME OF DECLARANT _____]. SHOULD I/WE, SELL, TRANSFER, COMMERCIALY EXCHANGE OR OTHERWISE DISPOSE OF THE MOTOR VEHICLE(S) WITHIN [NUMBER _____] YEARS AFTER UTILIZING THIS CONCESSION, THEN THE FULL SUM THAT HAS BEEN REMITTED BECOMES PAYABLE IMMEDIATELY, UNDER SECTION 32 OF THE CUSTOMS ACT. I/WE FURTHER DECLARE & CERTIFY TO THE JAMAICA CUSTOMS AGENCY THAT ALL INFORMATION GIVEN IN RESPECT OF THE MOTOR VEHICLE(S), INCLUDING THE MODEL YEAR, IS TRUE, CORRECT AND COMPLETE. I/WE FURTHER DECLARE THAT I/WE INDEMNIFY THE GOVERNMENT OF JAMAICA AND/OR THE JAMAICA CUSTOMS AGENCY AGAINST ALL CLAIMS, BY ANYONE: (1) ARISING OUT OF ANY BREACH OF THE CUSTOMS LAWS IN RESPECT OF THE MOTOR VEHICLE(S); (2) DUE TO ANY INACCURACY, FRAUD, FORGERY, MISREPRESENTATION, OR INAUTHENTICITY IN RELATION TO THE INFORMATION OR DOCUMENTATION SUBMITTED TO THE JAMAICA CUSTOMS AGENCY CONCERNING THE MOTOR VEHICLE(S) INCLUDING THE MODEL YEAR; (3) IN THE EVENT OF ANY LIABILITY ARISING FROM THE USE OF OR RELIANCE ON ANY OF THE AFORESAID INFORMATION OR DOCUMENTATION; AND/OR(4) ANY OTHER ISSUE THAT MAY ARISE IN RESPECT OF THE INFORMATION OR DOCUMENTATION.
